United Way of Northern New York (UWNNY) directs resources toward high-impact, vital initiatives throughout Jefferson, Lewis, and St. Lawrence Counties. Community Impact programming is guided by data, community input, and a commitment to improving outcomes in health, education, and financial stability. Funding decisions are informed by a volunteer review process that includes individuals with lived experience, helping to ensure equity and alignment with community needs.

UWNNY provides support to low-income workers, referred to as ALICE (Asset-Limited, Income-Constrained, Employed), connecting them to coaching, resource navigation, and emergency assistance. The program helps stabilize under-resourced workers, reduce turnover, and strengthen long-term workforce retention across the region. UWNNY facilitates Bridges Out of Poverty training for employers and community partners, helping to build shared understanding and practical strategies for supporting under-resourced populations.

The organization launched a new direct service initiative in September 2024: a licensed School Aged Child Care program in partnership with Morristown Central School. This program addresses the shortage of affordable childcare in rural areas.

Services include academic support, enrichment activities, and healthy snacks.

In 2024, UWNNY sponsored programming impacted the lives of 37,637 individuals across the tri-county area, including 14,292 children.
